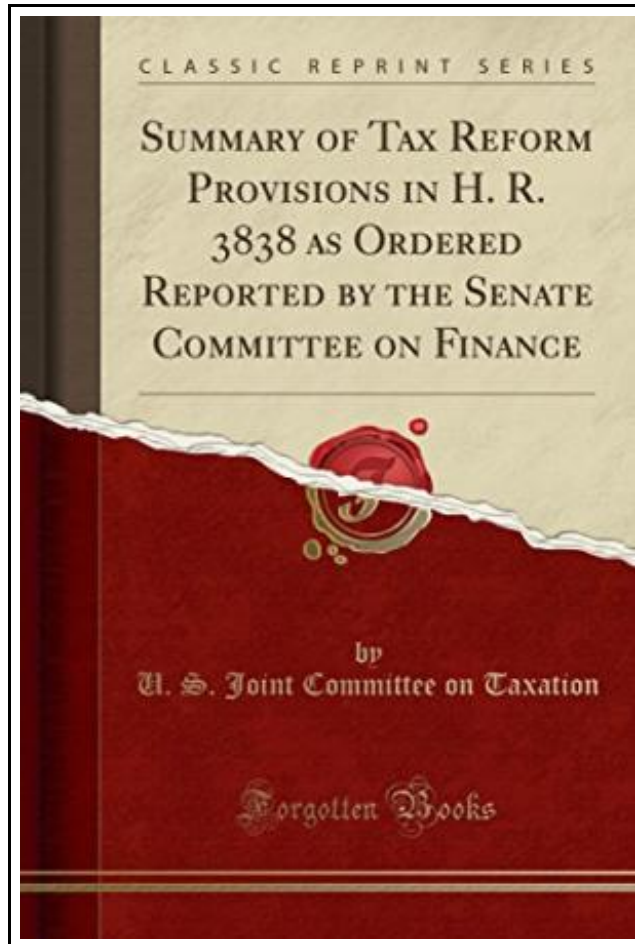



The bill nearly halves the top individual tax rate to 27 percent and reduces the top corporate tax rate by nearly one - third to 33 percent. The bill is estimated to be revenue neutral; over the next five years, the tax burden of individuals would be reduced by approximately \$100 billion, while corporate taxes would increase by a similar amount. The reduction in tax rates is achieved by broadening the base of the corporate and individual income taxes through the elimination of various tax benefits and preferences allowed under present law. Many of the new provisions increase the tax base of upper - income individuals and allow a reduction in the top tax rate without altering the distribution of the tax burden. These provisions, such as strict new limitations on the use of investment losses to shelter other income and an expanded minimum tax, seek to ensure that high-income taxpayers cannot reduce their effective tax rates to disproportionately low levels. The bill is intended to simplify the tax system for nearly all Americans. The bill replaces the 15 tax brackets for individuals under present law with two rates percent and 27 percent. Over 80 percent of all taxpayers will have a top rate no higher than 15 percent. Large increases in the standard deduction (the zero bracket amount, under present law) and a near doubling of the personal exemption will eliminate the tax liability of approximately six million low-income individuals.
